The fact of residing on the campsite implies the unreserved acceptance of the internal regulations. Any breach of these rules may lead to the legal expulsion of the offender, without being able to claim reimbursement of the sums paid.

CONDITIONS OF BOOKING :

Except for legitimate reasons justifying our refusal to contract (in particular unavailability of the product), the reservation becomes effective with our agreement and after reception of the contract completed and accompanied by a payment of 30% + 16€ of non-recoverable handling charges.

Accommodation: the accommodation is available on the day of arrival from 4pm to 7pm. Departure on the day of arrival before 10.30 am.

Deposit: for a stay in an accommodation we will ask you for a deposit of 280 € which will be returned to you on the day of the inventory of fixtures (if there is no damage and if it is perfectly clean).

Cancellation: in the event of cancellation on your part, you will be held back or you will remain indebted: of the reservation fees as compensation for breach of contract.

An amount equal to 30% of the total cost of the stay if you cancel 30 days before the scheduled arrival date.

A fee equal to the total cost of the stay if you cancel less than 30 days before the scheduled arrival date, or if you do not show up on that date.

In the event of cancellation for reasons attributable to the campsite management company, the client will be reimbursed all sums paid.

Delayed or shortened stay: no discount will be granted in case of late arrival or early departure. The total amount of the stay remains due.

Payment for the accommodation must be made at least 30 days before the date of the contract.

Cancellation insurance for accommodation:

The tenant is informed that he has the possibility to subscribe a cancellation insurance covering his stay, and this via Campez Couvert. The subscription of such an insurance is the subject of a separate agreement describing the precise modalities of coverage and implementation of the guarantee.

Guests and visitors alike are required to comply with the house rules posted at the reception desk.

Excerpt from the rules of procedure...

Small animals are accepted on the campsite on presentation of the vaccination book (rabies vaccination compulsory) and must always be kept on a leash on the campsite. We ask you to pick up their dirt. They cannot be left alone in cars, accommodation or pitches.

Dogs of 1st and 2nd category are not accepted..

Visitors are allowed under the responsibility of their hosts, after reporting their presence at the reception desk and paying the prescribed fee. In any case, visitors' cars must park outside the campsite.

Vehicle traffic is limited to 10km/h and is prohibited between 10.30pm and 8.30am. (Access barriers closed). From 10.30 pm it is requested to respect the right to rest of its neighbours. The sound equipment must be adjusted accordingly.

* In accordance with the provisions of article L 1612-1 of the French Consumer Code, any customer of the campsite has the right to have recourse, free of charge, to a consumer mediator with a view to the amicable resolution of a dispute with the campsite operator.
