**CONDITIONS OF BOOKING :**

Except for legitimate reasons justifying our refusal to contract (notably unavailability of the product), the reservation becomes effective with our agreement and after receipt of the completed contract and accompanied by a payment of 30% + 16€ non-recoverable booking fees.

Campsite pitch: the pitch is available on the planned day from 2pm to 7pm, and departure before 12 noon. All rentals are nominative and cannot be sublet or transferred.

Deposit: for a stay on a pitch we will ask you for a deposit of 30 € which will be returned to you on the day of your departure.

**Cancellation:** in the event of cancellation on your part, you will be retained or you will still owe: the booking fees as compensation for breach of contract.

An amount equal to 30% of the total cost of the stay if you cancel 30 days before your planned arrival date.

An amount equal to the total if you cancel less than 30 days before the planned date of arrival, or if you do not show up on that date.

In the event of cancellation for reasons for which the company managing the campsite is responsible, the customer will obtain a refund of all sums paid .

Delayed or shortened stay: no reduction will be granted in the case of late arrival or early departure. The totality of the stay remains due.

For camping pitches, the balance is due on arrival, according to the date indicated on the contract.

**Assurance annulation pour les hébergements :**

The tenant is informed that he has the possibility of subscribing a cancellation insurance covering his stay, and this via Campez Couvert. The subscription of such an insurance is the subject of a separate agreement describing the precise terms of coverage and implementation of the guarantee.

Guests and visitors alike are required to comply with the house rules posted at the reception desk.

**Excerpt from the rules of procedure...**

Small animals are accepted on the campsite on presentation of the vaccination book (rabies vaccination compulsory) and must always be kept on a leash on the campsite. We ask you to pick up their dirt. They cannot be left alone in cars, accommodation or pitches.

Dogs of 1st and 2nd category are not accepted..

Visitors are allowed under the responsibility of their hosts, after reporting their presence at the reception desk and paying the prescribed fee. In any case, visitors' cars must park outside the campsite.

Vehicle traffic is limited to 10km/h and is prohibited between 10.30pm and 8.30am. (Access barriers closed). From 10.30 pm it is requested to respect the right to rest of its neighbours. The sound equipment must be adjusted accordingly.

\* In accordance with the provisions of article L 1612-1 of the French Consumer Code, any customer of the campsite has the right to have recourse, free of charge, to a consumer mediator with a view to the amicable resolution of a dispute with the campsite operator.
